4. Review Safety Signs (Decals), located on the machine as well as those shown in the Operator's manual
5. Show how to enter and exit operator's platform safely, with brake set and engine off. Use hand grabs and access steps.
6. Demonstrate use and maintenance of seat belt.
7. Demonstrate how to start, stop, turn and park the Broom.
8. Explain the safe travel speed of the Broom
9. Advise availability of other accessories, such as Gutter Broom & Front Dozer Blade.
10. Demonstrate how to mount and use optional attachments.
11. Explain use of the optional Operator cab and optional air-conditioning system.
12. Explain recommended fueling and lubricating procedure.
13. Advise never to use the Broom in an environment with explosive-dust or gases or with flammable material near exhaust.
14. Review maintenance procedure on Service Schedule decal and in Operator, Service & Parts Manual.
15. Explain "Warranty Policy" and limitations to Owner/Operator. Warranty Statement printed in Operator, Service & Parts Manual and Warranty Brochure enclosed in delivery packet.
